1	Call to order	Rachel	5:48 pm	Rachel calls the meeting to order.

4	Message from the Chair	Rachel	5:51 pm	Rachel reminds everyone that CFRU is an important institution of U of G, that is a valuable platform for alternative voices. She adds that everyone in the room should feel proud of the work that is being done.
5	Station Manager Report	Vish	5:51 pm	Vish welcomes questions about the Station Manager's Report as well as any of the staff reports. Joel raises a portion from Christopher's report where he mentioned that several long-time programmers had left their shows. Joel wonders why

			<p>several programmers left at the same time. Christopher says those Joel is inquiring about left at the end of summer, but it is just a coincidence, and an unfortunate one at that. Christopher states that there was no larger reason for the programmers' departures. He also adds that this has resulted in some holes in the program schedule.</p> <p>Rachel brings up the disciplinary matter referenced in Christopher's report that required action from the Programming Committee. Christopher summarizes the incident where campus security got involved to deal with a past CFRU volunteer that was intoxicated and making inappropriate comments on-air. Christopher took this issue to the Programming committee and they agreed that the host of the show on which the old volunteer spoke on should be given a 2-month suspension, since hosts need to take responsibility for their guests.</p>

			<p>Rachel brings up something from another staff report about finding out from administration which CFRU volunteers had opted-out. Rachel thinks everyone's time could be spent more wisely. Vish mentions that the University of Guelph administration told us that they can't really help us with that task anyway. Instead, if we really want to know, we can just ask volunteers if they opted out.</p> <p>Joel has a question about the Anti-Oppression training mentioned in Jenny's report. Specifically, he asks if there is funding allocated for this. Vish says we are still in the process of figuring out where all the money will go. Joel asks when the Anti-Oppression training would take place and Vish responds that typically trainings like these are a good idea when we get a bunch of new volunteers. Vish thinks this training will be a good idea post-AGM since there will be new board members and since we have new</p>

			<p>volunteers this semester.</p> <p>Brooke asks about Alex's report where she mentions that she has very few volunteers in the music department right now. Christopher chimes in that overall, the number of volunteers this semester is increasing, meaning that a lot of people have gone through orientation training. However, some of these volunteers haven't yet taken steps to start actively volunteering at the station, such as working in the music department or taking steps to get a show. Vish reiterates that lots of volunteers have come in, but after orientation we don't know what areas of CFRU people are interested in.</p> <p>Brooke suggests that if Alex is feeling overwhelmed and like she needs more help, that maybe the music department can be emphasized in orientation sessions. Vish says, while this is a good idea, we can only suggest, as ultimately it</p>

6	Financial Report	All	6:04 pm	<p>Mike summarizes the financial report, which reports only up to September 30; the first month of the fiscal year.</p> <p>He also says that the finance committee met the previous Friday to discuss the budget since the student fees have come in. At the meeting they talked about coming up with a revised budget that is more accurate and more informed considering the actual amount of money that was received from student fees. The station received more fees from opt-ins than was originally projected, but we should expect the fees to be lower for the winter semester. Scotty wants to know if we know what the actual opt-in percentage is for this semester. Vish says we got 76% of what we received last fall and that 20% of students opted-out.</p> <p>Vish mentions that the University of</p>

			<p>Guelph's campaigns were all focused around opting-out, whereas other places like Lakehead University's campaigns were focused around getting students to opt-in. Lakehead's radio station lost 70% of their funding as a result.</p> <p>The opt-out period was during the summer, when students were not really around and weren't engaged in campus activity, so that could be a potential reason why not that many people opted-out. The opt-out period for the winter semester starts October 28 and is open for 2 weeks. As this is in the heart of the semester, more students may be aware and may opt-out, so we should be prepared for this.</p> <p>Joel asks if anyone is advertising and encouraging people to opt-out of services, and Vish responds that conservative groups in support of the government may be pushing it. However, there is no active campaign for opting-out.</p>

			<p>Christopher adds that he has seen some trolling comments on Facebook, but nothing formal.</p> <p>Before the opt-out period, we drew lots of attention to it by protesting the government but such campaigns have quieted down since then. The better strategy may just be to emphasize what we do and what we offer, which has been the strategy of the CSA.</p> <p>Joel observes that there are some students in the room and asks them how much they were aware of the opt-out process. Tom says he was not really aware of it and that he may have received an email about it. Sophia remembers getting an email but did not opt-out of anything.</p> <p>Scotty wonders if we are saving money operating with less staff members and asks if there is a plan for hiring new staff members to fill the vacant positions. Vish responds that we are not at liberty to say at</p>
